## Global Equitability Pricing (GEP)



(Effective as and from 11 December 2024)

## PURPOSE

Our mission at PRIMER-e is to empower researchers everywhere. In line with this important mission, we are pleased to offer *Global Equitability Pricing* (GEP). Specifically, customers residing in certain countries will qualify to receive a percentage discount off our standard prices for software products and <u>online</u> workshops\*. Our **GEP discounts** for eligible countries are scaled carefully by reference to the <u>Price Level Ratio</u> (PLR) published by the World Bank for each country.

We recognise that currency conversions alone do not necessarily capture important differences in purchasing power for different countries. Importantly, the PLR does *not* correspond to GDP (gross domestic product). Instead, the PLR is calculated by the World Bank's International Comparison Program (ICP) based on costs associated with purchasing a "basket of goods" in each country, thus it reflects genuine fundamental differences in <u>purchasing power</u>.

## TABLE OF GLOBAL EQUITABILITY DISCOUNTS

PRIMER-e's **Global Equitability Pricing** (GEP) discounts are given in full in the Table below as a **percentage discount** off our standard (US) prices for each individual country. Currently, there are 155 countries eligible for a GEP discount. (Countries ineligible for a GEP discount at the present time show a value of 0.00% in the table below). Discounts reflect the most recent information published by the World Bank and are updated regularly. Note that we are unfortunately unable to sell products or services to residents of the following countries, due to strict US sanctions: *Cuba, Iran, North Korea, Syria,* and *Venezuela*. We are also currently unable to sell products and services to residents of *Russia*, due to the political situation in Ukraine.
